**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:**

**Section 1. APPROPRIATION. --Two million dollars  
(\$2,000,000) is appropriated from the general fund to the  
children, youth and families department for expenditure in  
fiscal year 1999 for the purpose of funding community  
alternatives to corrections incarceration programs for youths.  
Any unexpended or unencumbered balance remaining at the end of  
fiscal year 1999 shall revert to the general fund.**
