or in use. To qualify for use, the year-of-manufacture plate shall be an authentic plate issued in New Mexico during the motor vehicle's model year.

C. For a one-time fee of twenty-five dollars (\$25.00), which shall be in addition to the regular motor vehicle registration fees, any owner of a motor vehicle that is thirty or more years old may apply to the division to use a year-of-manufacture plate on his vehicle.

D. Upon the sale or transfer of a motor vehicle bearing a year-of-manufacture plate, and upon payment of a ten dollar (\$10.00) transfer fee in addition to the regular motor vehicle registration fees, the plate shall remain with the vehicle and be transferred to the new owner.

E. Ten dollars (\$10.00) of the fee collected pursuant to Subsection C of this section shall be retained by the department and is appropriated to the department to defray the cost of issuing the special year-of-manufacture registration plates."




