MAKING APPROPRIATIONS TO FUND INTERIM AND PRE-SESSION EXPENSES OF THE LEGISLATURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRI ATI ONS. --

There is appropriated from the general fund to the legislative council service for fiscal year 1999, to be disbursed on vouchers signed by the director of the legislative council service, the following:

for travel expenses of legislators other (1) than legislative council members, on legislative council business for committee, travel, staff and other necessary expenses, for other interim committees expenses and for other necessary interim legislative expenses for fiscal year 1999, eight hundred eighty-six thousand five hundred dollars
