MAKING AN APPROPRIATION FOR SUPPORT PERSONNEL, SUPPLIES AND

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred twenty-three
thousand four hundred dollars (\$123,400) is appropriated from
the general fund to the board of regents of New Mexico
highlands university for expenditure in fiscal year 1999 for
the purpose of hiring support personnel, reproducing needed
materials and related expenses to administer the new four
