AN ACT

MAKING AN APPROPRIATION TO ESTABLISH A STATEWIDE BASIC MATH AND SCIENCE PROGRAM RELATED TO THE STUDY OF NEW MEXICO'S HISTORY, CULTURE AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Two hundred fifty thousand dollars (\$250,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1999 for the purpose of establishing a statewide basic math and science program for grades kindergarten through eighth, related to the study of New Mexico's history, culture and natural resources. The program shall be administered by eastern New Mexico university. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
