Section 1. APPROPRIATION. -- One hundred thirty thousand four hundred eighty dollars (\$130,480) is appropriated from the general fund to the human services department for expenditure in fiscal year 1999 for the purpose of contracting for a teenage pregnancy prevention program in Dona Ana county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
