**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:**

**Section 1. APPROPRIATION. -- Five hundred thousand dollars (\$500,000) is appropriated from the general fund to the human services department for expenditure in fiscal year 1999 to provide emergency services statewide to qualified low-income families and individuals. Any unencumbered or unexpended balance remaining at the end of fiscal year 1999 shall revert to the general fund.**
