AN ACT

MAKING AN APPROPRIATION FOR TUITION SCHOLARSHIPS TO STUDENTS WHO ARE MEMBERS OF THE NEW MEXICO ARMY NATIONAL GUARD OR THE NEW MEXICO AIR NATIONAL GUARD.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Nine hundred seventy-five thousand dollars (\$975,000) is appropriated from the general fund to the department of military affairs for expenditure in fiscal years 1999 through 2002 for the purpose of granting tuition scholarships to students who are residents of New Mexico and who are active members of the New Mexico army national guard or the New Mexico air national guard. Any unexpended or unencumbered balance remaining at the end of fiscal year 2002 shall revert to the general fund.
