AN ACT

MAKING AN APPROPRIATION TO THE DEPARTMENT OF HEALTH TO DEVELOP
A FARM WORKER OUTREACH RESOURCE CENTER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Sixty-five thousand dollars
(\$65,000) is appropriated from the general fund to the
department of health for expenditure in fiscal year 1999 for
the purpose of developing a farm worker outreach resource
center to provide referral, education and counseling services
to farm workers. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1999 shall revert to the
general fund.
