BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Three hundred fifty thousand dollars (\$350,000) is appropriated from the general fund to the board of regents of New Mexico state university for expenditure in fiscal year 1999 for the purpose of creating and operating a center for energy technologies at New Mexico state university in Dona Ana county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
