AN ACT

MAKING AN APPROPRIATION TO THE UNIVERSITY OF NEW MEXICO FOR
HEALTH CARE SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Two million one hundred seventeen thousand
seven hundred dollars (\$2,117,700) is appropriated from the
general fund to the board of regents of the university of New
Mexico for expenditure in fiscal year 1999 for the following
purposes:

(1) one million dollars (\$1,000,000) for
primary care instructional support for the school of medicine;

(2) two hundred forty thousand dollars
(\$240,000) to continue implementation of the doctor of
pharmacy program;

1 (3) two hundred thirty-three thousand one
2 hundred dollars (\$233,100) for the certified nurse-midwife
3 program; and

4 (4) six hundred forty-four thousand six
5 hundred dollars (\$644,600) to reduce the credit against the
6 indirect cost-recovery revenue for the health sciences center.

7 B. Any unexpended or unencumbered balance
8 remaining at the end of fiscal year 1999 shall revert to the
9 general fund.
