AN ACT

MAKING AN APPROPRIATION FOR TRAINING AND PLANNING FOR WATER
SUPPLY PROTECTION IN THE RIO EMBUDO WATERSHED.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Two hundred twenty-five
thousand dollars (\$225,000) is appropriated from the general
fund to the New Mexico office of Indian affairs for
expenditure in fiscal year 1999 for the purpose of conducting
community hearings and water quality and public health
training to develop a water supply protection plan for the Rio
Embudo watershed in Taos and Rio Arriba counties. Any
unexpended or unencumbered balance remaining at the end of
fiscal year 1999 shall revert to the general fund.
