BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand dollars
(\$100,000) is appropriated from the general fund to the state
department of public education for expenditure in fiscal year
1999 for the purpose of funding the program service offered by
KANW radio station. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1999 shall revert to the
general fund.
