MAKING AN APPROPRIATION FOR THE PURPOSE OF CONTRACTING WITH A PRIVATE VENDOR FOR SERVICES THAT PROVIDE A NEUTRAL POINT FOR SUPERVISED VISITATION BETWEEN PARENTS AND CHILDREN IN BERNALILLO COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred twenty-five thousand dollars (\$125,000) is appropriated from the general fund to the prevention and intervention division of the children, youth and families department for expenditure in fiscal year 1999 for the purpose of contracting with a private vendor for services that provide a neutral point for supervised visitation between parents and children in Bernalillo county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the
