AN ACT

MAKING AN APPROPRIATION TO INCREASE PARTICIPATION OF
UNDERREPRESENTED STUDENTS IN UNDERGRADUATE AND GRADUATE
EDUCATION PROGRAMS AT NEW MEXICO STATE UNIVERSITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Thirty thousand dollars
(\$30,000) is appropriated from the general fund to the board
of regents of New Mexico state university for expenditure in
fiscal year 1999 for the purpose of assisting underrepresented
students in transitioning from two- to four-year institutions
of higher education. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1999 shall revert to the
general fund.
