## AN ACT

MAKING AN APPROPRIATION FOR THE INVESTIGATION OF THE EFFECTS

OF MUNICIPAL AND INDUSTRIAL WITHDRAWALS ON THE ANIMAS AND SAN

JUAN RIVERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred fifty thousand dollars (\$150,000) is appropriated from the general fund to the office of the state engineer for expenditure in fiscal year 1999 for the purpose of investigating the effects of municipal and industrial withdrawals on the Animas and San Juan rivers. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
