AN ACT

MAKING AN APPROPRIATION FOR AN ACADEMIC, CULTURAL,
TECHNOLOGICAL AND SCIENTIFIC OLYMPICS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Twenty-three thousand two hundred dollars (\$23,200) is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1999 for the purpose of operating an African-American academic, cultural, technological and scientific olympics for students in grades nine through twelve. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
