MAKING AN APPROPRIATION FOR A YOUTH INITIATIVE TO BUILD SELF-ESTEEM PROJECT IN BERNALILLO AND OTERO COUNTIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Five hundred three thousand one hundred thirty-six dollars (\$503,136) is appropriated from the general fund to the department of health for expenditure in fiscal year 1999 for the purpose of contracting for services to operate a youth initiative to build self-esteem project at community centers in Wells Park, Westside, Westgate and Los Padillas in Bernalillo county and at community centers in Alamogordo and Tularosa in Otero county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
