AN ACT

MAKING AN APPROPRIATION FOR A MEDIA LITERACY PROGRAM
STATEWIDE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Four hundred fifty thousand dollars (\$450,000)
is appropriated from the general fund to the state department
of public education for expenditure in fiscal year 1999 for
the purpose of conducting a statewide media literacy program
including:

- (1) expansion of media literacy as substance
abuse prevention;
- (2) dissemination of technology and media
literacy programs;
- (3) unique educational CD-ROM technology

- 2 (4) support of the Taos talking picture
- 3 festival media literacy forum;
- 4 (5) increase of Native American media
- 5 literacy programs;
- 6 (6) development of a comprehensive critical

- 9 young children" program;
- 10 (8) expanding free training for rural and
- 11 disadvantaged groups;

16 B. Any unexpended or unencumbered balance
17 remaining at the end of fiscal year 1999 shall revert to the
18 general fund.
