AN ACT

MAKING AN APPROPRIATION FOR SUPPORT PERSONNEL, SUPPLIES AND
RELATED EXPENSES FOR ADMINISTERING THE NEW FOUR SKILLS
EXAMINATION FOR BILINGUAL ENDORSEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand four
hundred dollars (\$100,400) is appropriated from the general
fund to the board of regents of New Mexico highlands
university for expenditure in fiscal year 1999 for the purpose
of hiring support personnel, reproducing needed materials and
related expenses to administer the new four skills examination
for bilingual endorsement to certify proficiency in the
Spanish language. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1999 shall revert to the
general fund.
