RELATING TO HIGHER EDUCATION FINANCIAL ASSISTANCE; AMENDING
THE DEFINITION OF "STUDENT" IN THE WICHE LOAN FOR SERVICE ACT;
MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 21-29-2 NMSA 1978 (being Laws 1997,
Chapter 126, Section 2) is amended to read:

"21-29-2. DEFINITIONS. -- As used in the WICHE Loan for
Service Act:

A. "commission" means the commission on higher
education; and

B. "student" means a New Mexico resident who is a
graduate of a New Mexico high school or has resided in New
Mexico for five consecutive years immediately preceding
application to the program and who attends or is about to

1 attend a graduate or professional program of education through
2 the auspices of the Compact for Western Regional Cooperation
3 in Higher Education. "

4 Section 2. APPROPRIATION. -- Five hundred thousand dollars
5 (\$500,000) is appropriated from the general fund to the
6 commission on higher education for expenditure in fiscal year
7 1999 for the student support fees for the WICHE loan for
8 service program pursuant to the WICHE Loan for Service Act.
9 Any unexpended or unencumbered balance remaining at the end of
10 fiscal year 1999 shall revert to the general fund.
