BE IT ENACTED BY THE LEGI SLATURE OF THE STATE OF NEW MEXI CO:
Section 1. Section 10-11-41 NMSA 1978 (bei ng Laws 1987, Chapter 253, Section 41) is amended to read:
"10-11-41. STATE LEG SLATOR MEMBER COVERAGE PLAN 1-AMOUNT OF PENSI ON-FORM OF PAYMENT A.--
A. Under state legi slat or member coverage plan 1, the annual amount of pensi on under formof payment $A$ is equal to [ hundred fifty dollars (\$250)] five hundred dollars (\$500) multiplied by credited service as a legislator or I i eutenant governor, if the member served as legislator or I i eutenant governor after Decenber 31, 1959.
B. Under state legi sl at or member coverage pl an 1 , the annual amount of pension under formof payment $A$ is equal to [forty dollars (\$40.00)] ei ghty dollars (\$80.00) multiplied by credited service as a legislator or lieutenant governor, if all service as a legislator or lieutenant governor is prior to J anuary 1, 1960."

Section 2. Section 10-11-42 NMSA 1978 (bei ng Laws 1987, Chapter 253, Section 42) is amended to read:
" 10-11-42. STATE LEG SLATOR MEMBER COVERAGE PLAN 1-MEMBER CONTRI BUTI ON RATE. - - A member under state legi slat or nember coverage plan 1 shall contribute [ one hundred dollars (\$100)] t wo hundred dollars (\$200) for each year of credited service earned after Decenber 31, 1959."
