MAKING AN APPROPRIATION TO THE GOVERNING BOARD OF THE ALBUQUERQUE TECHNICAL-VOCATIONAL INSTITUTE TO CONTRACT FOR A STUDY TO DETERMINE THE FEASIBILITY OF DEVELOPING A JOINT AVIATION TRAINING CENTER AT ALBUQUERQUE INTERNATIONAL SUNPORT IN ALBUQUERQUE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand dollars (\$100,000) is appropriated from the general fund to the governing board of the Albuquerque technical-vocational institute for expenditure in fiscal year 1999 for the purpose of contracting for a study to determine the feasibility of developing a joint aviation training center at the Albuquerque international sunport. The study shall assess the current and potential capability of the Albuquerque international sunport

to operate a joint aviation training center, identify and develop a growth strategy for the training center and determine the equipment and facility requirements that will be necessary to operate a viable and competitive training center. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
