Section 1. APPROPRIATION. -- One hundred fifty thousand dollars (\$150,000) is appropriated from the general fund to the New Mexico office of Indian affairs for expenditure in fiscal year 1999 for the purpose of creating quarterly state-tribal legal institutes to discuss and identify possible solutions to outstanding issues of concern to both the state and Indian nations, tribes or pueblos located in New Mexico. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
