AN ACT

RELATING TO PUBLIC EDUCATION; PROVIDING FOR A TWENTY PERCENT SALARY INCREASE FOR WORLD-CLASS TEACHERS WHO HAVE BECOME CERTIFIED BY THE NATIONAL BOARD FOR PROFESSIONAL TEACHING STANDARDS; MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. WORLD-CLASS TEACHERS--SALARY INCREASE--
APPROPRIATION.--

A. During fiscal year 1999 the state department of public education shall distribute an amount to each local school district necessary to provide a twenty percent salary increase to each teacher within that school district who has been certified by the national board for professional teaching standards.

B. Five hundred thousand dollars (\$500,000) is
