MAKING AN APPROPRIATION FOR THE BLOCK BOUNDARY SUGGESTION  
PROJECT IN PREPARATION FOR REDISTRICTING AFTER THE NEXT  
FEDERAL DECENNIAL CENSUS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred seventy-five  
thousand dollars (\$175,000) is appropriated from the general  
fund to the legislative council service for expenditure in  
fiscal years 1998 through 2000 for phase 2 of the block  
boundary suggestion project in preparation for redistricting  
after the next federal decennial census. Any unexpended or  
unencumbered balance remaining at the end of fiscal year 2000  
shall revert to the general fund.
