AN ACT

RELATING TO PUBLIC PEACE, HEALTH AND SAFETY; CREATING AN ADDITIONAL JUDGE IN THE SIERRA COUNTY MAGISTRATE COURT; MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 35-1-30 NMSA 1978 (being Laws 1968, Chapter 62, Section 32) is amended to read:

"35-1-30. MAGISTRATE COURT--SIERRA DISTRICT.--There shall be [one magistrate] two magistrates in Sierra magistrate district with a court in Truth or Consequences."

Section 2. APPROPRIATION. -- Fifty thousand dollars (\$50,000) is appropriated from the general fund to the administrative office of the courts for expenditure in fiscal year 1999 for the purpose of paying salaries and benefits and providing furniture, equipment and supplies for one magistrate .123362.1
