11 REQUESTING THE MOTOR VEHICLE DIVISION TO DEVELOP A PERMANENT
12 HANDICAPPED LICENSE PLATE FOR THOSE PEOPLE PERMANENTLY
13 DISABLED TO AVOID BIENNIAL RENEWAL OF HANDICAPPED PARKING
14 PERMITS.

16 WHEREAS, partially disabled drivers must renew their
17 permits to park in handicapped parking spaces on a biennial
18 basis; and

19 WHEREAS, the current biennial renewal imposes unnecessary
20 and unfair costs on those drivers who are permanently
21 partially disabled; and

22 WHEREAS, unnecessary and duplicative medical costs as
23 well as bureaucratic costs are incurred by existing
24 procedures;

25 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE

1 STATE OF NEW MEXICO that the motor vehicle division of the
2 taxation and revenue department be requested to develop a
3 permanent handicapped parking license plate for those drivers
4 who are certified by a medical professional to be permanently
5 partially disabled; and

6 BE IT FURTHER RESOLVED that the motor vehicle division
7 report its progress in developing such a license plate to the
8 appropriate interim legislative committee by November 1, 1998;
9 and

10 BE IT FURTHER RESOLVED that a copy of this memorial be
11 transmitted to the secretary of taxation and revenue.
