WHEREAS, water is a vital resource of New Mexico; and WHEREAS, Article 4 of the decree of the supreme court of the United States in <u>Arizona v. California</u>, 376 U.S. 340, allocated eighteen thousand acre-feet of additional water from Gila river sources; and

WHEREAS, Public Law 90-537, Section 303(f)(1) provides for contracting for the eighteen thousand acre-feet of water authorized in the Arizona_v._California decree; and

WHEREAS, regional and local water planning for the Gila and San Francisco river basins have identified shortfalls of

water supply for future needs;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the interstate stream commission initiate negotiations to contract with the secretary of the interior for the authorized eighteen thousand acre-feet of water; and

BE IT FURTHER RESOLVED that the interstate stream commission investigate alternatives for providing payment of the New Mexico apportioned capital construction costs of the central Arizona project and develop recommendations; and

BE IT FURTHER RESOLVED that the interstate stream commission report the progress of contract negotiations, development of payment alternatives and recommendations to the water, utilities and natural resources committee or to a successor interim committee before the committee's final meeting in 1998; and

BE IT FURTHER RESOLVED that a copy of this memorial be transmitted to the interstate stream commission.
