WHEREAS, there are community-based and free-standing health care providers in communities that also have contracts with managed care organizations, and that are ready and willing to serve medicaid beneficiaries; and

WHEREAS, the survival of these providers is threatened by network providers who do not refer medicaid patients to them; and

WHEREAS, medicaid patients may have continuity of care interrupted with providers who have served their needs for a long time if network providers insist on referring these patients to themselves; and

WHEREAS, medicaid patients are entitled to free choice of providers represented by a contract with their chosen managed care organization;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the human services department be requested to limit or eliminate the ability of network providers to refer medicaid managed care patients to themselves; and

BE IT FURTHER RESOLVED that the department monitor this activity through contract oversight; and

BE IT FURTHER RESOLVED that the use of network providers be curtailed and that their use be expressly prohibited when .120024.1


