REQUESTING THAT THE LABOR DEPARTMENT NOT DIRECT A PERSON TO PROVIDE HIS SOCIAL SECURITY NUMBER ON THE OUTSIDE OF AN ENVELOPE USED BY THAT DEPARTMENT TO PROCESS UNEMPLOYMENT COMPENSATION CLAIMS.
