**A MEMORIAL**

**REQUESTING THE CITY OF ALBUQUERQUE AND BERNALILLO COUNTY TO  
WORK COOPERATIVELY AND ESTABLISH THE NECESSARY JOINT POWERS  
AGREEMENT TO MEET THE NEEDS OF THE ATRISCO AND FIVE POINTS  
AREA.**

**WHEREAS, in the 1960s and 1970s the city of Albuquerque  
made various annexations into the Atrisco and the Five Points  
area of the unincorporated area of the south valley in  
Bernalillo county; and**

**WHEREAS, these annexations did not respond to the true  
needs of those communities; and**

**WHEREAS, the city of Albuquerque annexed a road that  
originates at city limits and ends in established commercial  
zones within the unincorporated area of Atrisco and Five  
Points; and**

1           WHEREAS, valuable tax bases were converted overnight from  
2 Bernalillo county to the city of Albuquerque so that the  
3 county residents did not receive this revenue; and

4           WHEREAS, New Mexico citizens in the Atrisco and the Five  
5 Points areas have had to grapple with faulty 911 responses to  
6 fire and police emergencies; and

7           WHEREAS, there is much need in these annexed areas as  
8 well as in areas bordering Bernalillo county for improved  
9 infrastructure, social programs, recreational programs,  
10 cultural programs and educational programs that neither the  
11 city of Albuquerque nor Bernalillo county have addressed;

12           NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF  
13 REPRESENTATIVES OF THE STATE OF NEW MEXICO that the city of  
14 Albuquerque and Bernalillo county be encouraged to work in  
15 tandem to establish a multiservice center in the Atrisco and  
16 Five Points area for the community, including youth and senior  
17 citizens; and

18           BE IT FURTHER RESOLVED that the city of Albuquerque and  
19 Bernalillo county be encouraged to establish a joint powers  
20 agreement to resolve the needs of the Atrisco and Five Points  
21 areas, including storm drain systems, road improvements and a  
22 coordinated emergency response system; and

23           BE IT FURTHER RESOLVED that the city of Albuquerque and  
24 Bernalillo county submit a report to the legislature by  
25 November 15, 1998; and
