STATE ROADS THE RESPONSIBILITY OF COUNTIES TO MAINTAIN.

WHEREAS, the state highway and transportation department told Union county and other county officials in December 1997 that the department has the authority to determine whether a road is the responsibility of the county or the state; and

WHEREAS, the department has told some county officials that counties will have the obligation to maintain some state highways; and

WHEREAS, many counties do not have the equipment or the budgets to maintain state highways; and

WHEREAS, state highways are essential to the economy and welfare of rural citizens;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the state highway and transportation department be asked to obtain the approval of boards of county commissioners prior to designating state roads the responsibility of counties to maintain; and

BE IT FURTHER RESOLVED that the New Mexico legislative council be requested to direct the appropriate committee to study the responsibility of the state highway and transportation department to maintain state roads and report findings and recommendations to the legislative council by November 1, 1998; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the secretary of highway and transportation and to the New Mexico legislative council.
