13 WHEREAS, New Mexico MESA, incorporated, a nonprofit
14 organization, is part of a national initiative promoting
15 educational enrichment for pre-college students from
16 historically underrepresented ethnic groups; and

17 WHEREAS, currently in seventy-four schools statewide, the
18 New Mexico MESA program has grown dramatically since its
19 introduction in 1982 in seven schools, and is celebrating its
20 fifteen-year anniversary this year statewide, and it provides
21 thousands of middle, junior and high school students with
22 year-round support and career guidance; and

23 WHEREAS, New Mexico MESA activities include tutoring;
24 independent study; academic, university and career counseling;
25 field trips and competitions; leadership workshops; summer

1 enrichment, employment and mentorship programs; and
2 scholarship incentives; and

3 WHEREAS, New Mexico MESA provides support not only to
4 students but to their teachers, families and community; and

5 WHEREAS, through New Mexico MESA's efforts, participating
6 students receive the educational enrichment experiences and
7 practical help they need to achieve academic excellence and
8 prepare for college majors in mathematics, engineering and the
9 sciences;

10 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
11 STATE OF NEW MEXICO that it designate February 2, 1998 as "New
12 Mexico MESA Day"; and

13 BE IT FURTHER RESOLVED that it hereby recognize and
14 applaud the New Mexico MESA organization for its dedication to
15 preparing minority students for careers in mathematics,
16 engineering and the sciences; and

17 BE IT FURTHER RESOLVED that a copy of this memorial be
18 transmitted to New Mexico MESA, incorporated.
