A JOINT MEMORIAL

REQUESTING THE STATE BOARD OF FINANCE TO LOAN THE CITY OF ELEPHANT BUTTE MONEY TO MEET START-UP COSTS.

WHEREAS, the citizens of Elephant Butte recently voted to incorporate as the one hundred first municipality in New Mexico; and

WHEREAS, there is no money in the city treasury to operate in the first year;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the state board of finance be requested to loan two hundred fifty thousand dollars (\$250,000) to the city of Elephant Butte for its first year of operations as the one hundred first municipality; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the state board of finance and to the city of
