Section 1. It is proposed to amend Article 2, Section 6 of the constitution of New Mexico to read:

"No law shall abridge the right of the citizen to keep and bear arms for security and defense, for lawful hunting and recreational use and for other lawful purposes [but nothing herein shall be held to permit the carrying of concealed No municipality or county shall regulate, in any weapons]. way, an incident of the right to keep and bear arms."

Section 2. The amendment proposed by this resolution shall be submitted to the people for their approval or
