11 PROPOSING TO SELL THE RETIREE HEALTH CARE AUTHORITY PROPERTY

15 and approval of any sale of real property for a consideration  
16 of one hundred thousand dollars (\$100,000) or more; and

17 WHEREAS, the retiree health care authority is desirous of  
18 selling real property and improvements, legal description set  
19 forth below; and

20 WHEREAS, the retiree health care authority proposes to  
21 sell the retiree health care authority property located at 625  
22 Don Gaspar avenue in Santa Fe county, New Mexico, and more  
23 particularly described as:

24 Lots 21 and 22, Block 2 as shown on amended plat of  
25 South Capitol Subdivision, City of Santa Fe, County

1 of Santa Fe, New Mexico.; and

2 WHEREAS, the property shall not be sold for less than the  
3 value of the property established by the taxation and revenue  
4 department using generally acceptable appraisal techniques for  
5 this type of property;

6 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE  
7 STATE OF NEW MEXICO that the proposed sale be hereby ratified  
8 and approved pursuant to the provisions of Section 13-6-3 NMSA  
9 1978; and

10 BE IT FURTHER RESOLVED that a copy of this resolution be  
11 transmitted to the retiree health care authority.
