10 A JOINT RESOLUTION

11 PROPOSING THE SALE OF CATHEDRAL PARK TO THE CITY OF SANTA FE.

13 WHEREAS, Section 13-6-3 NMSA 1978 requires ratification
14 and approval of any sale, trade or lease of property for a
15 period exceeding twenty-five years in duration or of a value
16 of one hundred thousand dollars (\$100,000) or more; and

17 WHEREAS, the property control division of the general
18 services department was requested by the legislature to
19 negotiate with the city of Santa Fe to sell Cathedral park to
20 the city; and

21 WHEREAS, an agreement has been reached for the city to
22 purchase the park for two hundred eighty thousand dollars
23 (\$280,000); and

24 WHEREAS, the agreed value represents its value as a park
25 and not as a commercially developed property; and

1 WHEREAS, the city of Santa Fe agrees to maintain
2 Cathedral park as a park and to maintain it for the enjoyment
3 of all citizens and visitors;

4 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
5 STATE OF NEW MEXICO that the general services department be
6 authorized pursuant to Section 13-6-3 NMSA 1978 to sell
7 Cathedral park to the city of Santa Fe for two hundred eighty
8 thousand dollars (\$280,000); and

9 BE IT FURTHER RESOLVED that copies of this resolution be
10 transmitted to the secretary of general services and to the
11 mayor of the city of Santa Fe.
