A JOINT RESOLUTION

PROPOSING TO SELL LA VILLA RIVERA, MARIAN HALL AND CATHEDRAL
PARK IN SANTA FE IN SANTA FE COUNTY.

WHEREAS, Section 13-6-3 NMSA 1978 requires ratification
and approval of any sale of real property by a state agency
for a consideration of one hundred thousand dollars (\$100,000)
or more; and

WHEREAS, the property control division of the general
services department is desirous of selling real property and
improvements, legal description set forth below; and

WHEREAS, the property control division proposes to sell
La Villa Rivera, Marian hall and Cathedral park in Santa Fe
county, New Mexico and more particularly described as:

8 **TOGETHER WITH** all buildings, improvements and fixtures
9 located thereon or appurtenant thereto;
10 **WITH WARRANTY COVENANTS.**

11 By acceptance of this deed, the grantee
12 covenants and agrees that the above-described
13 property shall not, at any time prior to October 1,
14 2001, be used for a use which is competitive with
15 the grantor's use of the facility known as "St.
16 Vincent Hospital" on St. Michaels' Drive in Santa
17 Fe, New Mexico, as an acute care hospital.; and

18 **WHEREAS,** the property shall not be sold for less than the
19 value of the property established by the taxation and revenue
20 department using generally acceptable appraisal techniques for
21 this type of property after review by the capitol buildings
22 planning commission;

23 **NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE**
24 **STATE OF NEW MEXICO** that the proposed sale be hereby ratified
25 and approved pursuant to the provisions of Section 13-6-3 NMSA
