AN ACT

**RELATING TO PHARMACY LICENSES; ENACTING A NEW SECTION OF THE
PHARMACY ACT TO REMOVE THE BOARD OF PHARMACY FROM
ADMINISTRATIVE ATTACHMENT TO THE REGULATION AND LICENSING
DEPARTMENT.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**Section 1. A new section of the Pharmacy Act is enacted
to read:**

**" NEW MATERIAL BOARD OF PHARMACY--REMOVAL FROM
ADMINISTRATIVE ATTACHMENT TO REGULATION AND LICENSING
DEPARTMENT. --**

**A. The board of pharmacy is not administratively
attached to the regulation and licensing department.
Executive Order 86-10 issued pursuant to legislative authority
provided in Laws 1983, Chapter 297, Section 30 is void as it**
