### AN ACT

MAKING APPROPRIATIONS AND AUTHORIZING EXPENDITURES FOR THE STATE FAIR COMMISSION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

- Section 1. SHORT TITLE. -- This act may be cited as the "State Fair Commission Appropriations Act".
- Section 2. DEFINITIONS.--As used in the State Fair Commission Appropriations Act, "other state funds" means:
- A. unencumbered balances in state agency accounts appropriated by the General Appropriation Act of 1998; and
- B. all revenue available to state agencies from sources other than the general fund and federal funds.
- Section 3. FORMAT.--The general format of the appropriations set forth in the State Fair Commission Appropriations Act with respect to symbols used, column . 125877.1
