"66-3-874. SAFETY BELTS REQUIRED. --

A. It is unlawful for any person to buy, sell, lease, trade or transfer from or to New Mexico residents at retail an automobile [which] that is manufactured or assembled commencing with the 1964 models unless the vehicle is equipped with safety belts installed for use in the left front and right front seats.

B. After January 1, 2000, a person shall not operate on the highway or street a school bus not equipped . 124470. 2
