AN ACT

MAKING AN APPROPRIATION TO PROVIDE PROGRAMS AND SERVICES FOR  
MEDICAID-INELIGIBLE YOUTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One million two hundred fifty thousand dollars (\$1,250,000) is appropriated from the general fund to the children, youth and families department for expenditure in fiscal year 2000 for the purpose of contracting for services and programs for medicaid-ineligible youth.

These services shall include, but are not limited to, after-school programs, life skills building programs, mentoring, home-based services, behavior management programs, respite, parental support and education, independent living programs, substance abuse treatment and foster care independent living programs and group homes and shelters.
