AN ACT

MAKING AN APPROPRIATION FOR CONTINUATION OF A STATEWIDE
ASSESSMENT OF NURSING NEEDS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION--PURPOSE. --One hundred fifty
thousand dollars (\$150,000) is appropriated from the board of
nursing fund to the board of nursing for expenditure in fiscal
years 1999 through 2002 to contract for a statewide study of
the need for additional nurses and the types of education and
training necessary to meet New Mexico's health care demands.
Any unexpended or unencumbered balance remaining at the end of
fiscal year 2002 shall revert to the board of nursing fund.

Section 2. EMERGENCY.--It is necessary for the public
peace, health and safety that this act take effect
immediately.
