

15	Section 1. COUNTY OFFICIALSMINIMUM WORK HOURSA
16	county clerk, treasurer, assessor or sheriff in a class A, B
17	or C county with an annual salary of thirty-five thousand
18	dollars (\$35,000) or more shall work a minimum of forty hours
19	per week in the service of his elected position and may
20	receive the same health and leave benefits as provided to
21	county employees. The county clerk, treasurer, assessor or
22	sheriff shall keep his own records.
23	Section 2. EFFECTIVE DATEThe effective date of the
24	provisions of this act is January 1, 2000.




