AN ACT

MAKING APPROPRIATIONS FOR SMALL BUSINESS DEVELOPMENT CENTERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS. --

A. The following amounts are appropriated from the general fund to the department of finance and administration for expenditure in fiscal year 2000 for the following purposes at small business development centers:

- (1) sixty thousand dollars (\$60,000) for statewide professional development;
- (2) fifty thousand dollars (\$50,000) to install and maintain a statewide management information system;
- (3) ninety thousand dollars (\$90,000) to establish a small business development center in Taos; .125986.1

- B. Any unexpended or unencumbered balance remaining at the end of fiscal year 2000 shall revert to the general fund.
