

15	Section 1. Section 3-52-5 NMSA 1978 (being Laws 1965,
16	Chapter 300, Section 14-53-5) is amended to read:
17	"3-52-5. [ <del>LIMITATIONS ON POWER</del> ] <u>TRANSPORTATION</u>
18	<u>CONTRACTS</u> [ <del>A.</del> ] All contracts for work, material or labor in
19	connection with [ <del>such</del> ] <u>a</u> transportation <u>system</u> shall be let in
20	the manner provided by law for the letting of other contracts
21	by the municipality.
22	[B. Transit service may not be extended to points
23	outside the county in which the city is located unless prior
24	approval is obtained from the state corporation commission and
25	other regulatory bodies having jurisdiction in the matter. ]"
