AN ACT

MAKING AN APPROPRIATION FOR WOMEN'S SPORTS AT CERTAIN PUBLIC POST-SECONDARY EDUCATIONAL INSTITUTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Eight hundred twenty thousand dollars (\$820,000) is appropriated from the general fund for expenditure in fiscal year 2000 for the purpose of increasing women's sports activities to comply with Title 9 of the federal Education Amendments of 1972 to the following entities in the following amounts:

- (1) three hundred thousand dollars (\$300,000) to the board of regents of the university of New Mexico;
- (2) three hundred thousand dollars (\$300,000) to the board of regents of New Mexico state university;
