The 7 issuance of the other permit shall be subject to a lottery by the department or by an unincorporated nonprofit organization 8 9 dedicated to conservation of wildlife, as determined by the 10 commission.

C. All money collected from the issuance and sale of the bighorn sheep enhancement [permit] permits shall be credited to the game protection fund to be used exclusively for bighorn sheep preservation, restoration and management."
