(2) to the extent practicable, maintenance of the rural primary care delivery infrastructure;

4 (3) that the department's approach is
5 consistent with national and state health care reform

8 medicaid-eligible individuals are not identified as such
9 except as necessary for billing purposes.

C. The department may exclude nursing homes, intermediate care facilities for the mentally retarded, medicaid in-home and community-based waiver services and residential and community-based mental health services for children with serious emotional disorders from the provisions of this section.

16 D. Each contract for a managed care system entered 17 into by the department pursuant to this section shall provide 18 that the increase in the cost per medicaid recipient from one 19 contract year to the next shall not exceed the average rate of 20 increase in nationwide health insurance costs for the previous calendar year, as calculated by the superintendent of 21 22 insurance using accepted national indices. The superintendent 23 of insurance shall, by February 1 of each year, notify the 24 department of the rate that health insurance costs increased in the previous calendar year.
